The Linguistic Society of Japan Regulations on the Treatment of Copyrighted Materials

Established on November 18, 2006 Revised on June 18, 2011 Revised on November 28, 2015

(Purpose)

1. The purpose of these regulations is to regulate the treatment of the articles and related materials (hereafter copyrighted materials) published in *Gengo Kenkyu* and *LSJ Meeting Handbook* so that it may not cause any inconvenience to either the authors or the Linguistic Society of Japan (hereafter the LSJ).

(Granting to the LSJ the Right of Reproduction and the Right of Public Transmission)

2. With respect to the copyrighted materials published in *Gengo Kenkyu* whose authors are clearly stated, permission to exercise the rights to reproduce their copyrighted materials and make them publicly available in Japan and overseas (hereafter the right of reproduction; note that "reproduction" will cover both reproduction and public transmission) shall be granted solely to the LSJ by the authors. The right of reproduction for copyrighted materials whose authors are not clearly stated shall belong solely to the LSJ. The authors shall be deemed to have accepted these regulations at the time of contributing their copyrighted materials to *Gengo Kenkyu* and shall comply with these regulations when they reproduce their copyrighted materials or make their copyrighted materials publicly available through media such as the Internet.

(Reproduction for Limited Distribution)

3. When the distribution of copyrighted materials published in *Gengo Kenkyu* is limited to specific persons or organizations, such as attendances at classes or workshops, research groups, or organizations or associations supporting research activities, and the purposes of their use are expressly limited to those for education or research, those who want to reproduce the copyrighted materials may do so without giving notice to the LSJ, regardless

of their being the authors of the copyrighted materials or not, provided that the sources of the copyrighted materials shall be specified.

(Terms and Conditions of Authors' Reproduction of their Copyrighted Materials)

4. Except for the cases provided under Section 3, when the author of any copyrighted material wishes to reproduce it by herself/himself or have it reproduced by any third party, the author shall give advance notice to the LSJ. In addition, the author shall make references to the LSJ and *Gengo Kenkyu*, as well as the issue and pages of *Gengo Kenkyu* in which the copyrighted material is published as its source, and shall specify that its original was printed and published in *Gengo Kenkyu*. If the author has corrected misprints or other errors or has added some material, she/he is required to state it clearly in the reproduced version. The LSJ cannot claim any right to any part of the money that the author may be paid for reproducing her/his copyrighted material on the grounds that it has been granted the right of reproduction.

(Terms and Conditions of Authors' Reprinting their Copyrighted Material in Collected Papers)

5. The author of any copyrighted material published in *Gengo Kenkyu* may include, or have any third party include, it in collected papers, and publish, or have such a party publish, such collected papers, subject to the terms and conditions provided under Section 4. In addition, if any charge is paid to the author related to her/his copyrighted material, the LSJ may not claim its rights on the grounds that it has been granted the right of reproduction.

(Terms and Conditions of Reproduction by the LSJ)

6. When the LSJ carries out, or has any third party carry out, the reproduction of copyrighted materials, such reproduction shall be extensively beneficial to members of the LSJ including the authors themselves. In addition, the reproduction of copyrighted materials shall be subject to approval by the board of councilors. (Income Payable to the LSJ from the Reproduction of Copyrighted Materials) 7. Should consideration be paid to the LSJ for the reproduction of copyrighted materials, such consideration shall be treated as income to the LSJ.

(Terms and Conditions of the LSJ's Reprinting the Copyrighted Materials in Collected Papers)

8. When the LSJ includes, or has any third party include, copyrighted materials published in *Gengo Kenkyu* in its own collected papers, the LSJ shall not only comply with the terms and conditions provided under Section 6 but also give advance notice to the authors of the copyrighted materials.

(Infringement by Authors of any Third Party's Copyrights) 9. In the event that any notices given by any third party should reveal the fact that any copyrighted material in *Gengo Kenkyu* should infringe any third party's copyrights, any and all obligations or responsibilities arising from such infringement shall be born by its author.

(Copyrighted Materials before Establishment of these Regulations) 10. The LSJ may treat the copyrighted materials published before the establishment of these regulations in accordance with these regulations. In the event that the author of any copyrighted material published in *Gengo Kenkyu* before the establishment of these regulations should express any objections to the LSJ, such objections shall be discussed for resolution so as not to cause any disadvantage to either the author or the LSJ.
